

Boss Manufacturing Company And Subsidiaries Credit Agreement Terms and Conditions

- Liability: Personal liability is assumed for owners or partners or proprietorships or partnerships, until notice of incorporation, ownership change, or disbandment is received by BOSS.
- Past Due Accounts: BOSS reserves the right to charge 1.5% per month as a service charge on overdue accounts and unpaid balances or 18% per annum, but not to exceed the maximum amount permitted by applicable state law.
- Cost of Collection and Attorneys Fees: If Buyer fails to pay any amount when due, including service charges, Buyer agrees to pay the full amount of any cost or expenses, including reasonable attorney's fees incurred by BOSS, in the collection of such overdue amounts by litigation or otherwise.
- Sales Tax: If you are tax exempt, please send a completed tax exemption certificate (use form enclosed).
- Timely Notification: No shipping or delivery claims will be accepted unless made within 10 days after receipt of merchandise. All Buyer claims resulting from incorrect invoicing must be submitted to Boss in writing within 60 days of invoice date, or Buyer agrees to accept invoice as billed. BOSS will not make adjustments for claims after 60 days from invoice date.
- Payment Terms: Payment terms are stated on each invoice and are effective from invoice date. Any dispute of these terms must be received by BOSS within 10 days of invoice.
- Returned Checks: Buyer agrees to reimburse BOSS for any charges incurred to BOSS as the result of any protested checks returned by your bank, and for any fees or cost incurred by BOSS to collect the face value of said checks (in states where allowed by law).
- Authority of Parties: No soliciting agent, sales representative or employee of BOSS shall have the power to waive any of the terms or provisions hereof, or to incur additional obligations, or to make additional representatives or warranties on behalf of BOSS unless same are evidenced by an agreement, in writing, signed by a duly authorized officer of BOSS or the Credit Manager. Signer for Buyer represents that he is a duly authorized agent for Buyer, empowered to sign this document and that the information supplied on the Credit Agreement form is true and accurate.
- **Governing Law:** This agreement shall be governed by the laws of the state of Illinois.
- Conditions: The account established hereunder and the credit extended hereby shall not be effective until this application is accepted by BOSS in Kewanee Illinois. Buyer represents that this account is for business use only and that Buyer will not purchase products from BOSS hereunder for personal, family, agricultural or household use.
